Key Transaction Highlights

- On November 9, 2022, Molded Devices, Inc. (MDI), a provider of high-precision, value-added plastic
 component manufacturing solutions for medical and non-medical applications, announced the acquisition of
 two companies from Schauenburg Hose Technology, GlobalMed Inc. (Canada) and Schauenburg Truplast
 (China) (together, "GlobalMed"). Financial terms of the transaction were not disclosed.
- GlobalMed is a pure play medical tubing and extrusion manufacturer with over 40 years of plastic extrusion expertise, serving medical device original equipment manufacturers (OEMs) in clinical areas such as anesthesia, respiratory, ventilation, surgical (smoke evacuation) and sleep apnea.
- The business combination deepens MDI's capabilities for medical device OEMs and supports the Company's robust customer relationships in the healthcare market.
- SVB Securities acted as financial advisor to MDI and TruArc Partners.
