SVB Securities Serves as Joint Bookrunner for agilon health's (Nasdaq: AGL) \$1,868 Million Follow-On Offering

## **Key Transaction Highlights**

- Publicly launched and priced on May 15th post-close.
- Deal includes a secondary public offering of 86,884,353 shares of common stock (an upsizing from the
  previously announced offering of 70,000,000 shares) and a 30-day option to purchase up to an additional
  7,726,955 shares of common stock from the selling stockholders.
  - The shares of common stock are being sold at a public offering price of \$21.50 per share.
- In addition, agilon health has agreed to purchase 9,614,806 of the 86,884,353 shares of the common stock included in the offering, agilon health intends to fund the purchase with cash on hand.
- CD&R Vector Holdings, L.P. ("CD&R"), an affiliate of Clayton, Dubilier & Rice, LLC and a selling stockholder in
  the offering, has also entered into a lock-up agreement under which CD&R has agreed not to sell its remaining
  100 million shares of agilon health's common stock for a period of 900 days after May 15, 2023. Following the
  completion of the offering, CD&R will hold approximately 26.6% of the common stock, or approximately 24.7%
  if the underwriters exercise in full their option to purchase additional shares.
- This is SVB Securities' first bookrun offering for agilon and 22nd bookrun equity offering in 2023.
